How to interpret this table

The percentage of proposals with a given score or higher is shown, per ranking list. Green shows the funding range (main-list).

For example:

- in the CHE ranking, 8,33% of all proposals submitted in the ranking list (total 132) scored 95 or higher. The funding cut off score is 95,6.
- in the ENG ranking, 12,53% of all proposals submitted in the ranking list (total 383) scored 94 or higher. The funding cut off score is 94,8.
- in the SOC ranking, 12,88% of the proposals scored less than 70.
